President's Report to 2015 AGM



The year just ending has seen major change and development in Melb PC's key services for members.

PC Update has now been completely transformed into PC Update Newsletter. We have been fortunate to have two volunteer editors — first lan Rankin, and then Gary Taig, who have sustained our monthly publication. The decision to move to the Newsletter format has led to substantial financial savings while enabling us to maintain this central service to members.

The move of our email hosting from outlook.com to Office 365 Enterprise E1 (as our new service is known) was completed when we switched over in February 2015, almost a year to the day since we moved from our in-house service (of blessed memory) to outlook.com. In the space of a single year, those changes brought us a very long way from our legacy in-house service. Our mailboxes have increased in size five thousand times, from 10MB to 50GB. Members' cloud storage (now OneDrive for Business) has increased from none at all to 1 terabyte (1000 gigabytes). Outlook.com brought with it other new services: an online calendar and an address book. We still have those with Office 365, and yet more new services have arrived. We are gradually working out how to make the best use of them.

The long-awaited move of our legacy internet services from their hosting in Burnley (at an AAPT facility which we rented) to our own server room at Moorabbin, was finally consummated in December 2014. This was a difficult and complex operation. We were able to restore many services as soon as our servers had been plugged in and switched on at Moorabbin, but others required more work. Two legacy services that are not yet restored are the members' websites and the newsgroups.

Discussion continues about the possibility of restoring these services and decisions will be made by the incoming Committee. It seems unlikely that we shall be able to restore the newsgroup service, but more likely that web-hosting for members can be reintroduced.

The move to the Newsletter form for PC Update, and the transfer of our internet services to Moorabbin, have led to a saving in annual costs to Melb PC of around \$100,000. Together with the rise in subscriptions agreed by our 2014 AGM, they have placed our finances on to a much more secure footing for the future.

A highlight of the year has been the unveiling of our new website. We now have a website with a fresh look and a new focus

on key member services and information. Some of the most important developments are behind the scenes, where the content management system we have chosen to support the site enables different office-holders (such as SIG conveners) to manage their own areas.

The website is still a work in progress. We expect to see further refinements as needs become clearer, both of current members and of visitors who may become members.

At the start of the past year we celebrated Melb PC's 30th anniversary as an incorpo-

rated association in Victoria. Towards the end of the year, in late September, 50 members gathered together to consider Melb PC's preferred future. That was a successful event, most ably animated by **Bill Ford**, to whom many thanks. We hope and expect that the momentum developed at that event can be maintained into the coming year.

Finally I would like to thank the retiring Committee for their work during a challenging year. I trust this report shows that Melb PC has made important steps towards future sustainability while maintaining the services most valued by its members.





Annual General Meeting Agenda

- 1. Apologies.
- 2. Minutes To consider and if thought appropriate pass the following resolution:"That the Minutes of the 31st Annual General Meeting held on 5th November 2014, be approved as a true and correct record."
- 3. To consider and if thought appropriate pass the following resolution:That Rule 2 (first paragraph only) be replaced with "The purposes of the Association are to conduct on a non profit basis activities to help members learn and use systems and devices using various technologies, especially computing, software, and communications technology (inc. the Internet and World Wide Web, personal computers & devices), to achieve the following outcomes;"

Note: Motions 3-14 are **special resolutions** and require not less than three-quarters of the members voting, whether in person or by proxy, to vote in favour of the resolution.

- 4. To consider and if thought appropriate pass the following resolution:That Rule 12 (1) be replaced with "The Association shall determine the amount of the annual subscription rates for each class of membership at a general meeting."
- 5. To consider and if thought appropriate pass the following resolution:That Rule 14 (2) be replaced with "The Committee may determine the terms of membership for student or concessional members. The members of the Association may vary such terms and conditions by ordinary resolution at a general meeting."
- 6. To consider and if thought appropriate pass the following resolution:That Rule 14 (5) be added as "Corporate

Members. A corporation may in writing appoint two natural persons as its representatives and may replace representatives as required. A representative of a corporation shall have the same rights, duties and obligations as members including the right to appoint a proxy, however only one representative may become a member of the Committee." Then old Rules 14 (5) and 14 (6) be re-numbered as Rules 14 (6) and 14 (7) respectively.

- 7. To consider and if thought appropriate pass the following resolution:That Rule 31 (5) (e) be replaced with "to appoint an appropriately qualified person to review the financial statements according to the Act."
- 8. To consider and if thought appropriate pass the following resolution:-That Rule 32 be replaced with "(1) The Association shall hold an election to be conducted by postal vote or appropriately secure electronic vote immediately prior to the annual general meeting for the positions of President, Vice President, Treasurer and Secretary and eight other Committee members. (2) The notice for the election shall include nomination forms that stipulate the closing date and time for receiving of nominations, and the address of the Returning Officer. (3) An eligible member of the Association shall be nominated by two other members. The nomination must be in writing and be on the nomination form (or copy of it) provided to members with the notice of election and be signed by all three members."
- 9. To consider and if thought appropriate pass the following resolution:That Rule 37 (2) be replaced with "The quorum for a general meeting is the presence (physically, by proxy or as allowed under rule 36) of the greater of 30 members or 2% of the members entitled to vote."

10. To consider and if thought appropriate pass the following resolution:That Rule 37 (3) (b) (1) be replaced with "The meeting must be adjourned to a date not more than 35 days after the adjournment; and"

11. To consider and if thought appropriate pass the following resolution:That Rule 52 (4) be replaced with "Members nominating for positions may submit a statement of 200 words or less to the Returning Officer for publication on the Association's web site."

12. To consider and if thought appropriate pass the following resolution:-That Rule 52 (5) be replaced with "A member may nominate for election for one or more officer position(s) as well as a Committee member position." AND that Rule 53 (3) be replaced with "Votes will be counted on a simple majority basis for each Officer position and each committee position. Votes for officer positions will be counted first, and in the order President, Secretary, Treasurer, and Vice President. Where a person is elected as an officer and is the nominee in the election for any other office or as an ordinary member of the Committee, the second and any further nomination shall lapse. Votes are not transferable between positions."

- 13. To consider and if thought appropriate pass the following resolution:That Rule 31 (1) (b) be replaced with "at least 21 days notice of a general meeting in any other case."
- 14. To consider and if thought appropriate pass the following resolution:That the numbering in Rule 74 be corrected, by replacing the repeated occurrences of the paragraph numbers (2) and (3) with (4) and (5) respectively.

Random Access

John Swale reports on Questions and Answers from the opening session of the recent monthly meeting and from members' written submissions.

Questions and **Answers**

Q: I have a laptop which had a boot failure and a message telling me to insert a bootable disk. I rebooted and used F10 to get into the BIOS. There was no hard disk listed in the boot sequence section. I did a test with the HP software and it showed the disk was OK. This has happened intermittently. The drive is about six months old. Do you think there is a connection problem with the hard drive cable?

A: The HP diagnostics are sitting on a partition on the drive. It may be a loose connection. Turn the laptop

over and remove and reinsert the drive ensuring there is a good connection. Another suggestion is to use Hiren's Boot Disk first to examine the whole drive. It may be the boot sector of the operating system is faulty but the HP diagnostic partition is OK.

Q: I'm using Internet Explorer as my browser and I am annoyed by an occasional popup with the message "Only secure content displayed". How can I stop this message appearing as I can't find where to turn it off?

If approved at the AGM, our Statement of Purposes will read:

- keeping members up to date on developments in computer and information technology and helping members to exchange information;
- representing members in public debate in areas of interest including law reform proposals;
- engaging with similar organisations; and
- carrying out activities that benefit the Association.

A: It will be in the options in the security area — Tools > Internet options > Security > Internet zone.

Q: I have a Samsung SSD. When I boot up, I get an error message that something is wrong and I need to run Checkdisk. I run it and there is nothing wrong. Next time I boot the machine I get the same message. I ran Samsung Magician and it says there is nothing wrong. Why is it continuing to come up with some sort of a problem?

A: The is also a very good freeware version of the SSD utility called SSD Life that picks up extra information that the manufacturer's software does not. You can't stop the popup. There

is a chance the drive is wearing out as it has a limit on the number of read/writes it can do.

Q: I bought a laptop with Windows 8 pre-installed and it has the Windows 8 recovery partition there in case of trouble. It upgraded to Windows 8.1 and now Windows 10. Am I correct in thinking that that recovery partition is now useless and I can recover that drive space?

A: Yes the recovery partition is totally tied to the original operating system. So you can recover the space but, before doing so, make a drive image so you can recover if something goes wrong.

Microsoft Office 365 ProPlus for MelbPC Members

Subscriptions for Microsoft's desktop program suite Office 365 ProPlus are now available to Melbpc members at a reduced rate.

The programs included are; Word, Excel, OneNote, PowerPoint, Outlook, Publisher and Access. Members who take up this offer will be able to install the suite on up to 15 different devices: 5 computers (PC or Mac), 5 tablets (iOS/Android/Windows) and 5 smartphones (iOS/Android/Windows). The new 2016 versions are available now.

Microsoft Office ProPlus is available to members for an annual subscription, set for the first year and payable by members in advance*. Renewal for each year will reflect Microsoft's current price at the time of renewal.

After payment members will be able to download the program suite onto their own computers using their Office 365 login details (the same as they already use for email and other cloud services). As long as the subscription is maintained, members will receive updates and upgrades to the latest version of Office.

Our existing Office 365 Enterprise E1 service provides the 'cloud' versions of some Office applications: Word, Excel, PowerPoint and OneNote. These can be used during a login to Office 365 via the web. They do not include all of the features available on the desktop versions. Office 365 ProPlus provides the full versions of those applications, and others not available at in the cloud at all: Outlook, Publisher and Access. (Publisher and Access are not available in the Mac OS X version.) The ProPlus programs can be used when the computer is offline and not connected to the internet, as they are installed directly on the computer (or tablet/ smartphone).

Windows 7 with Access 2010 and Excel 2010 During our meeting we discussed:-

Removing duplicates records (email addresses) within a quiery. Open the query in SQL view and change the words to SELECT DISTINCT etc.

When a record is selected from a combo box the form displays the details of that record.

Open the form in design view and ensure the wizard is activated. Attach a combo box and select the option to find a record on the form. Click Next and ensure the first field is an auto number. Click ok.

Dave Botherway opened the meeting, beginning with the usual topic:

Recent Acquisitions:

Dave bought a smartwatch for \$29.95 (a bargain compared to Apple's smartwatch of \$349+). It connects to an Android phone via Bluetooth. It includes three hours talking time, remote control of phone camera, pedometer, alarm clock, stopwatch, sleep monitor and more. Dave mentioned *Crowd Funding*, whereby somebody puts up an idea on the net to see if people will help fund it. For example in July, Special Labs launched an earpiece (the world's smallest bluetooth headset) which was fully funded in three days. And the creators of the world's first \$9 computer (a chip) asked for and raised \$3,000,000 from crowd funding.

Questions and Answers

Q: Is there a simple way to save and back up LiveMail? A: Choose the Export option. It will export everything to another file, for example, an external file, while leaving the originals where they were. An Import is then used to restore the data.

Q: Why am I still getting updates for Office 2007 after I have upgraded to Office 2013?

A: The updates could be just for a remnant of Office 2007, such as OneNote. Look at what the updates are and check if you've removed everything.

With regard to all Windows Updates, there are three options:

- choose but not download
- · download then choose
- update automatically (the recommended method)

Care is needed with the last option – especially for large updates. A member was recently charged a lot extra by their service provider, when 3GB of Win 10 was automatically downloaded via their 3G connection (where the monthly allowance of only 1GB)

When reserving Win 10, you could get advice from Microsoft saying that Win-10 is not yet compatible with your machine. You may need to go to your manufacturer for support. For example, if you have a Medion computer, you may need to go back to Medion for drivers.

Favourite URLs

Jean de Neef talked about www.onelook.com, an online dictionary site which instantaneously accesses its extensive database of over a thousand dictionaries and provides you with a short list of definitions from which to choose. You can hear the word pronounced if you wish.

Alternatively, you can provide a definition, and onelook will come up with suggested words. And frustrated crossword addicts can pinpoint that elusive word by providing the definition plus the letters they've already managed to fill in.

Videos

Before the break we looked at two funny videos: a dog dining at a restaurant, plus a parody on the change of parliamentary leaders (Abbott to Turnbull).

Messy Desktop?

Dave now has only two icons on his demo PC desktop: an applications box and a demonstrations box. See *NimiPlaces* as free software to accomplish this technique. He also has a pinned list folder containing shortcuts which would normally be on the desktop.

File Manipulation

As a file manager, *Free Commando* automatically comes up with dual windows, where it is easy to drag and drop between the two windows. It also provides Tabbed Browsing allowing an easy swap between multiple folders on maybe two computers in a single browser window.

Another objective was to identify those areas where members felt they were in need of guidance or tuition, perhaps because of limited hands-on experience. The subsequent discussions were quite revealing and the subjects were incorporated into a general list of topics that could be covered at meetings in 2016 and beyond.

Use was made of the audio equipment that enables the presenter to remain seated with a laptop, and members to hear their comments from the loudspeakers at the back of the room.

Our main speaker was **Jan Whitaker** again, updating us on a subject she had touched on a couple of years ago when Cloud Storage was first being made available for non-professional computer users. The market has expanded enormously and there is now a multitude of providers with different capacities, prices and terms so it was difficult to sort out the "best plan" since much depends on the requirements of the user. For someone with only one device and limited use (for the extra storage) and sharing with other users, one of the free services such as *Drop-box*, *One-drive* or *Google-drive* is more than adequate but if more capacity is required for storing videos and sharing them, we were advised to thoroughly investigate the conditions and costs of other providers before signing up with them.

There were only a few member problems to be sorted following the tea and chat break, but some ideas were shared about services available at the Libraries including eBooks for "Bolinda" and the magazine service "Zinio"

Our October meeting opened with **Paul Woolard** welcoming all members present and guest **John Bain**.

The first session was Q&A with **George Skarbek**.

Q: When I install a new operating system such as Windows 10, I usually wait for all the bugs to be out before upgrading. However all those I've spoken to are delighted with Windows 10 so I wonder what your experience is with Windows 10?

A: My experience is not as positive as things went bad and I had to ring MS when upgrading one laptop. Other friends have also had trouble, one needing to install 5 times before rolling back to his earlier OS. However 80-85% updates will work. To most people the OS is not important. What is important to most people is their browser, email, office and photo editing programs etc. You should look at the risk and reward of upgrading and "if it ain't broke don't fix it".

If you want Windows 10 there will be a substantial upgrade in December so I would wait till early next year before upgrading.

Q: My daughter upgraded to Windows 10 and after a

month the PC stopped at the flash screen. Could this be related to Windows 10?

A: This is difficult to answer given what you have told me. It could be hardware or software. If the laptop doesn't POST (Power On Self Test) then the problem is hardware. If the operating system starts to load after the POST is completed, that means the POST is okay. If you see the flash screen that usually indicates the PC is ready to load the operating system.

Q: I want to transfer large DXF files (an AutoCAD drawing format) and wonder which of the two formats Binary or ASCII format is the better to use?

A: Generally I'd go with the Binary files as they will be very much smaller and load much faster. With ASCII the file will be physically large and take longer to save and longer to load. All information should be the same with either format.

Q: The initial Windows 10 download is saved on your computer waiting until you wish to install it. When Windows 10 gets upgrades presumably those upgrades don't go into the file that is sitting there. When you finally come to install Windows 10 in the first instance, won't it install the initial download that's been sitting there from day 1?

A: I would expect that is correct and it would then find all the upgrades and load them.

Q: I wonder what your opinion is of the cloud version of Office365 versus the PC based Office365ProPlus?

A: Office365 is free with your MelbPC membership and runs in a browser window, against Office365ProPlus which is a yearly subscription that you load onto your PC. The choice is up to each individual. My opinion is that the differences between Office 2010 and 2013 are very small. You need to have a reason to upgrade over what you are using at present, as recent changes to Office programs are more relevant to corporations.

Q: I use webmail for my email. I used to be able to take a group of about 25 email addresses from a Word document and paste them into the send box. When I do this now I receive an error message saying the addresses may not be correct. Can you help?

A: Is there anyone in the audience that can help Ken as I use Eudora for my email.

(Clem Pratt answers) I have found it impossible to turn a group of email addresses into a single list. No one else was able to give a solution to this problem.

Our next presentation was by **Dave Botherway** on "Windows 10 Issues (Those not discussed at the General Meeting)". As a member of the MicroSoft Insider Program Dave is running 5 copies of Windows 10, not all are running 100% but that is partially due to the multiboot systems and hardware Dave is running. Dave's presentation covered privacy and licencing issues

associated with Windows 10. Topics covered were:

- Automatic Windows 10 downloads
- Telemetry used to collect and share user information
- Sharing of Windows updates
- WiFi password sharing
- Window licence changes

In summary Dave believes MicroSoft is being proactive with future updates being tested prior to release through the Insider program. There is more openness and publicity about privacy issues than before. However the default settings in Windows 10 may leave people exposed, so check through the setting options and adjust these as necessary.

Dave's experience with Windows 10 so far is that it's an easy install, 30 minutes for a clean install and 2 hours for an upgrade. Windows 10 has proved 100% stable with faster startup and better security. There has been some problems with *nVidia* video drivers initially but these are gradually being fixed by nVidia.

After the break **George Skarbek** gave an insight on "How to Root an Android Phone". On a friends recommendation George installed an App that soon began to download multiple large advertisements that were quickly using up his data allowance. The App when uninstalled kept reappearing so another course of action was needed. A factory reset was one option but after studying internet articles George decided "rooting" the phone was his preferred option. Kingo was used and the rooting was not without its problems as the roque App proved difficult to remove, with Kingo twice failing to remove it. Success was achieved through good detective work and George now has a phone that is ad free with the bloatware removed. His apps now start faster and the phones battery life has been increased. George still does not have root access to his phone, but "Super User Access". This is not true root access but George decided the benefits of true root access was not worth the risk as he had achieved what he originally set out to do and that is to remove the roque app and remove the bloatware.

Our meeting in October comprised a Q&A session and two presentations.

The first presentation was "Controlling an Arduino from a Smartphone" by an invited speaker (and author) **John Boxall** from Tronixlabs. John demonstrated an app for an Android phone (Blynk, currently free) with an Arduino microcontroller. The smartphone was able to control the microcontroller, sending it "commands" that might, for example, open or close a garage door. The microcontroller could also send data or measurements to the smartphone, which could display graphs of it.

The second presentation was "Measurements & Electronics in the Car Industry". This was given by an engineer who once worked at GMH, and gave an overview of test and measurement in the development of cars, particularly engine emissions measurement. The talk gave some observations on Volkswagen's recent worldwide

problem of using "cheating software" in the engine computer of their 2 litre diesel engine. It is very difficult to imagine how this "cheating software" was used in the company for so long (6 years), and to understand how this would be possible if many company staff were aware of it.

The Gizmo session that followed was short and sweet without any significant outpourings of cash. In the Q&A segment that followed one member had a USB stick that requested formatting but balked at completing the task. This baffled everyone and attempts to do it at the meeting also failed. Fortunately it only had a small capacity. Another member was having trouble changing the time and date on his images and was advised that both Faststone and Irfanview were able to achieve the task.

After the break **John Hall** of the Multimedia group gave us a run-down on Raspberry Pi. This is the mini computer put together at Cambridge University to teach all students the basics of programming so that they could do more than just use a computer as an information and recording tool. U-Tube has a video clip showing John demonstrating a Rspberry Pi. The latest model has a Videocore 4 GPU, and comes with 1 GB RAM, 4 USB ports with Wi-Fi and HDMI and Composite O/P . The programming languages are Scratch and Python and it will output even to an old CRT. It runs from any Android

phone charger. However a case is a small extra charge. It is already a favourite for teaching *Minecraft* players programming. It may also be used as a media centre and for this the user downloads *Open Elec* and then *Kodi* as the mutimedia manager. *Noobs* is the program used to download any O/S if you want to use it as a general purpose computer. *Raspbian* can be downloaded if you want to use it as a Linux machine. There is even an App in the Google Play store if you want to control a camera from your telephone using a Raspberry Pi.

There is a lot of information on the computer in the internet community, the Multimedia group website has all the MagPi magazines for reference and of course the system has its own informative site. It is an astonishingly flexible piece of equipment and John did full justice to this with his usual enthusiastic delivery. It was a very informative meeting.

Windows 7 Session

Home Group suddenly appeared in the networking section of a member's notebook. This is possibly due to a Windows 7 update from about three months ago.

Peter Carpenter thought the hard disk on one of his computers could be about to fail. He used Spinrite, a free program from Gibson Research Corporation (www.grc.com), and it showed some hard drive problems. He cloned it to a new hard drive and replaced the old hard disk with the new one. This cleared the problem.

There is a free drive checking program called EASIS Drive Check. Go to www.easis.com/downloads for EASIS. EASIS also produces a free drive cloning tool and

Do you need to defragment a Windows 8 system? In Windows 8 "Defragment and Optimise Drives" is scheduled to run weekly. You can change the frequency or turn it off. Do a search for Defragmentation, select "Defragment and optimize your drives" then select "Change settings".

John discussed disk maintenance and urged the group to regularly run Chkdsk and a defragmentation program. Also remember to backup your email folder regularly. PC maintenance will be a topic for a future General session.

We discussed the possibility of running Windows 7 and Windows 8 on separate disks because of the problems trying to dual boot with a RAID system. One suggestion was to insert external switches in the power lines of each hard drive cable. Turn the PC off, turn the power on for the drive you want to be the boot disk, switch off the other one and restart the PC.

Where do you find the backup files when you use Windows 7 backup on auto backup. Press the "windows key", type backup, select "Backup and Restore" and Control panel opens up and shows the location of the backup files.

General Session

We talked about upgrading to Win 10 and it was pointed out that you must upgrade like to like i.e. Win 7 Pro to Win 10 Pro or Win 7 Home to Win 10 Home.

Peter Carpenter gave an excellent presentation on the use of One Note. To set the scene he started off with a preamble about the history of writing and note taking, starting with the Sumerians marking of clay tablets BC,

Gutenberg with his printing press in the 16th century, Graphite mines in England and the development of Plumbago pencils, Lazlo Biro with his ink biros in the 1930s, file folders to store written material, filofax for personal use, then computers with Notepad, WordPad etc. then onto OneNote and Office 365. Peter then ran through a comprehensive demonstration of OneNote as a modern way to take notes. He explained it is a freeform note taker. It can be used to save sections of web pages. This is made easy if you pin the snipping tool to the taskbar for quick access to copy the section of the web page to paste into OneNote. You can also include other files including audio and video. He finally pointed out Microsoft is spreading their applications to take in Android and Apple devices to assist collection of data and note taking on various devices.

A number of topics were raised and will be considered in future meetings.

- Libraries and how to use them.
- Various email programs. There was a general discussion on email programs and the different programs being used by people.
- The use of password managers and the need to ensure the use of strong passwords.

Members Helping Members



Internet Help (iHelp) is just one of Melb PC's services where members can obtain assistance from other members. It is also one that keeps records, and they reveal an interesting picture.

Internet Help records exist for the two classes of support service provided by iHelp, viz. *Jobs* which are initiated by a member completing an online form, and *First Aid* cases, which are the responses to telephone calls during the hours 10-3 on weekdays. iHelpers record details of their responses to members' queries on forms which are stored in two separate database tables.

Over the period of 32 months from 1 January 2013 to 31 August 2015, iHelp dealt with 4,854 individual cases ('tickets'), 2,691 being iHelp Jobs, and 2,163 First Aid cases. (There will have been more, to a level we cannot now recover, when queries were dealt with during system down-time, which happens occasionally, and is current because of changes at Westnet where our database has been hosted up to now.)

If these helping events were to be averaged across the 365 days of the year, iHelp is assisting in 4.7 cases every day. (Because of the First Aid schedule, the numbers will actually be bunched into the working week. Business is also lighter during public holidays and other distracting events.)

The record enables us also to determine how many members are involved, actually, how many membership numbers (as the record does not separate family members). So using 'member' here as shorthand for 'member with the same membership number', over those 32 months 1,329 different members were assisted. That number is greater than half the current total number of members of Melb PC, which is ~2,340 (still counting unique membership numbers; there are more people!).

I am well aware that iHelp is not the only channel through which Melb PC members help other members with their computer problems. It happens in SIG meetings, in monthly meetings, in the Newsgroups/Yammer, through Home Visit Assist and through Dial Help. There are also individuals who assist members, for example with their Optus Mobile Broadband devices, who are not part of any named Melb PC service.

'Members helping Members' is indeed Melb PC's core business.

Security Bug Could Threaten 950 Million Android Devices

In recent weeks, at least two potentially frightening new vulnerabilities have been discovered that could threaten an estimated 95 percent of the one billion devices running the Android operating system. The good news is that as of this writing, there have been no documented attacks on Android devices that take advantage of these two security vulnerabilities. The bad news is that now that information on these security vulnerabilities has been widely published, as well as presented at the recent Black Hat hacker and security convention in Las Vegas, it may only be a matter of time until some bad guys start to take advantage of these security vulnerabilities.

Google, the progenitor of Android, was promptly made aware of the vulnerabilities as soon as they were uncovered, and has produced patches and fixes for many of the Android devices that have these vulnerabilities. The problems is that with the exception of a few models of Nexus smart phones supported directly by Google, it is up to the phone manufacturers or the cell phone car-

riers to release the upgrades and patches to close these vulnerabilities. At present, none of the major third party security software publishers provide any protection, leaving many of us vulnerable.

One of these newly discovered Android vulnerabilities was given the moniker "Stagefright" by its finder, Joshua Drake, vice president of platform research and exploitation at Zimperium. Drake first reported on the Stagefright vulnerability in April, disclosing his findings to Google, which quickly developed and provided security patches to its Android partners. Most of these Google partners who have not yet provided the patches to their respective customers may not do so for months, if at all; many phone manufacturers and carriers have explicitly stopped supporting and patching older Android phones, which are still in use by the millions. In several media interviews, as well as his Black Hat presentation, Drake explained that, "All devices should be assumed to be vulnerable." As stated in a July 27 Forbes magazine interview, Drake said

that he believes that as many as 950 million of the one billion Android phones currently in use may be vulnerable to the Stagefright vulnerability. Drake went on to say that only older Android phones running versions of Android below version 2.2 will not be potentially affected by this bug.

It is important for Android users to understand that Stagefright is not a virus or other form of malware that could infect a phone, but is instead a bug, or unexpected and unforeseen security vulnerability in the Android software itself. This vulnerability is in the heart of the Android software that processes, plays and records multimedia files.

According to Drake, the security vulnerability may allow a hacker to illicitly access the targeted device by simply sending an MMS message (text message) or multimedia file. What is especially nefarious about the Stagefright vulnerability is that it can be taken advantage of by a hacker without any action by the user; the victim does not have to open or click on anything in order for the hacker to access a device. It is also theoretically possible for a hacker to capitalize on this vulnerability when an unsuspecting victim opens a purloined video file on a website. Once a hacker has taken advantage of this security gap in Android, he can access the victim's camera, microphone, and any data or images in the device's external storage. On some devices the hacker can also gain root access to the inner workings of the device.

In order to easily determine if a particular Android device is vulnerable to the Stage-fright vulnerability, Zimperium has released a free "Stagefright Detector App" available from the Google Play Store. A similar detector utility was just released by the security software company Lookout, which it simply calls "Stagefright Detector." While these utili-

ties will detect the vulnerability, it will still require a patch or other fix from the phone maker or the cell phone carrier supporting and updating the device.

When I first read of this Stagefright vulnerability and the availability of the detector, I downloaded and installed the detector. My year old Huawei Ascend Mate 2 phone, which had previously been upgraded by Huawei to Android Lollipop 5.1 (from 4.4), had the Stagefright vulnerability; coincidently, just yesterday (the day before typing this column), I received a patch from Huawei that, among other benefits, closed the Stagefright vulnerability on my phone. I reran the Stagefright detector from Zimperium to confirm the fix, and the vulnerability on my phone has definitely been patched by the recent update.

Another Android security vulnerability was disclosed at the recent Black Hat security convention. Well-known security company Check Mate disclosed this newly recognized bug, which it named "Certifi-Gate," which may potentially allow a hacker to take control of a victim's phone by utilizing the "Remote Support Tools (RSTs)" software that was installed on the phones by the manufacturers, often at the behest of the cell phone carriers selling those particular phones. Check Mate promptly notified the device makers and cell phone companies of the vulnerability.

According to Check Mate, there are millions of phones and tablets made by Samsung, ZTE, HTC, LG and other manufacturers that have incorporated this vulnerable "remote support" function software on their phones; according to Google, Nexus phones do not have this particular vulnerability. Using a security method known as digital certificates, hackers can spoof or counterfeit these supposedly secure digital certificates, allowing

them the same access to the internals and functions of the phone that had previously only been allowed to legitimate support personnel. Once the hacker has tricked the phone or tablet into accepting a spurious digital security certificates, he or she now has direct access to personal information stored on the phone and can turn on the microphone to remotely record conversations, track the location of the device and its user, and otherwise threaten the security and privacy of the victim.

While the device manufacturers and cell phone carriers were promptly notified of the vulnerability, it may be months, if ever, before they push the patches to this newly discovered vulnerability. Users can download a free utility that will show the user if a device is vulnerable to this remote support vulnerability. Written by Check Mate, the utility "Certifi-Gate Scanner" can be downloaded directly from the Google Play Store.

According to Check Mate, in order for hackers to take advantage of this vulnerability, the user must first download and install an application that contains the code that gives the hacker the access. The Google Play Store continuously monitors the apps that it makes available, checking them to make sure that they do not contain any malware. Check Mate advises that users to install applications from a trusted source, such as Google Play."

With the continual battles among users who seem to love arguing iOS and iPhones versus Android devices, iPhone users should not gloat over these Android vulnerabilities. At the Black Hat convention in 2013, which is where many hackers and crackers rub shoulders with security experts, the vulnerabilities of iOS devices, specifically iPhones, was discussed. In one of the presentations, despite the false but widely held belief that iPhones are immune to attack and are very secure by nature, researchers from the Georgia Institute of Technology were able to inject persistent, undetectable malware into iPhones, iPads and other iOS devices using the latest generation of the iOS operating system. Using a modified USB charger, nicknamed "Mactans" after a type of black widow spider, the researchers were able to compromise any current generation Apple device in under a minute.

Check your smart phone for these vulnerabilities, and do not download apps from any source other than reputable sources such as the Google Play Store or the Amazon App Store. Do not open any text messages from people that you do not recognize, although text messages can be spoofed just as emails are frequently spoofed. If you find that your device maker or phone carrier is providing a patch, update, or upgrade, strongly consider taking advantage of the offer and update your device immediately.

Is Windows 10 Spying on Us?

Is Windows 10 spying on me? I have been asked this question over and over. My answer may surprise you!

There has been considerable publicity about Windows 10 being used as a spying tool for Microsoft. Blogs and even some fairly reputable websites have jumped on this bandwagon. Most of this publicity is aimed at making headlines to increase readership. As you well know, today's news is dominated by racy headlines, even if they are sometimes trumped up. Some of this bad Microsoft publicity is focused on increasing public paranoia to sell products.

One of my followers recently sent me a copy of an audio interview of **Dr. Katherine Albrecht** in which she trashed Windows 10 in an article entitled "Windows 10 is full blown electronic tyranny." Dr. Albrecht is a very intelligent, articulate, and well-educated lady. In this interview she says that Windows 10 keeps the microphone turned on all the time to bug homes and offices across the country. She says that Microsoft is making a copy of every file you create with Windows 10. However she also uses this interview to promote her Startmail product which is supposed to keep you safer.

Let's see if I can negate a few of her claims. First, Windows 10 uses your microphone to let you verbally communicate with Cortana, their new virtual assistant. Cortana is not listening all the time unless you change the

settings and request that she does so. With the default settings, Cortana will only listen when you press the microphone button just like you would press the home button on an iPhone or iPad to ask Siri a question. Also, it is very easy to turn Cortana off or alternately to turn off your microphone completely.

Dr. Albrecht also says that Microsoft is sending the entire contents of all Windows 10 hard drives to their servers. Simply put, Microsoft is not copying all your files or documents. In the last month Windows 10 has been installed on 75 million devices. If Microsoft were to keep a copy of every one of those hard drives, we would be talking about thousands of Petabytes of data. To give you an idea of how much data that is, it is estimated that the entire written works of mankind from the beginning of recorded history in all languages would take up about 50 Petabytes. Simply copying that amount of data would take years plus an astronomical amount of storage space and electricity.

Another complaint is that Windows 10 can be set up to share Wi-Fi passwords. Again this is not turned on by default. You must choose to use it, and when you do, you must authorize it and the passwords are encrypted.

I can sum up the reality of this situation in one simple statement. With Windows

10, Microsoft is doing no more snooping, spying, or collecting data than other large companies like Apple, Google, and Amazon. I have read the Microsoft Services Agreement, the Windows license agreement, and the Microsoft Privacy Statement carefully. I have also looked at several privacy documents from Google and Apple. They all have similar clauses.

The bottom line is that if you use any cloud storage like Microsoft's One Drive or Apple's iCloud, if you use an online email system like Gmail, Outlook, etc., or if you use services to sync your documents between computers and/or mobile devices, there is a copy of your data out there in the Cloud. Your cell phone provider, your ISP, your cable provider, your smart TV, and even your car knows a lot about you, as well. Facebook, Twitter, Instagram and other social media sites probably know more about you than you might ever expect. Most companies are using your data to learn more about you, whether to give you better service or to send you targeted ads. If they are subpoenaed, they will give your information to the lawful agencies, but then if you have drawn that kind of attention to yourself, those agents may be busting

down your door and seizing your computers as well.

Right now Microsoft, Google, Apple, and Amazon are not spying on you or willfully giving the contents of your hard drive to anyone. Of course, an entire company could go bad, but currently you are at more of a risk from the bad guys and hackers than you are from the major companies. There are a lot of really good security people constantly monitoring the dealings of all the major companies.

So don't worry about Windows 10. It is no worse than Windows 7 or Mac OS X. If you want to be more secure, don't subscribe to any cloud services, don't use online email, and don't expect your data to sync between devices. If you want to be really secure don't access the Internet on your computer or tablet, don't use a cell phone, and don't buy a smart TV or any of the new Internet-connected devices, including a car.

Of course, if you do that you will be going back in time about 30 years. I know I wouldn't want to give up the knowledge, connectivity, productivity or entertainment that we have gotten from these devices.

Library Notes

Clemens Pratt, Librarian

During October I have placed several "magazine-style" publications on display in the library for the perusal of members when visiting our Moorabbin premises. One deals with Raspberry Pi, another with Windows 10 and a third is the latest edition of Choice Computer magazine (a regular publication from the Australian Consumers Association). They are for reference only and not available for loan. I'm keen to hear from any members whether they are of interest.

Navigating the library's coding scheme

When a book is catalogued for placement into the library, it is labelled on the spine with a code that determines its location on the shelves. A copy of the coding scheme is found attached to the glass fronted cabinet in the library itself.

For example, books on desktop publishing using Adobe Acrobat have code DPA, and under this code, books are numbered in order of receipt. Thus DPA-9 is the code for the title "Acrobat 5 PDF Bible". Books are located on the shelves in alphanumerical order of code. The coding scheme is not surprisingly imperfect, and in particular some books could be catalogued under more than one code, so if you are looking for a particular topic it's worth searching the library's catalogue listing using several alternative key words. The listing is available on the library's web page http:// www.melbpc.org.au/services/library/as well as on PC1 in the computer lounge at Moorabbin.
